## 2. LITERATURE REVIEW

## 2.1 Previous Studies

The results of the analysis the writer found messages in friendship in the form of acceptance of differences, the spirit of life, forgiveness and shared meant contained in the characters and storyline. The writer interested in analyzed messages about friendship seen through characters and storyline because many moral lessons was become an aimed of the study.

Komariati's (2017) study entitled "Analisis Aspek Sosial Budaya Dalam Novel Antologi Rasa Karya Ika Natassa" The result explained by described social facts, social strata, and socio-cultural functions made the allure of a novel. In the novel Anthology of Rasa by Ika Natassa, social facts were found in the form of friendship, loyalty, competition, materialism, hedonism and promiscuity. Which caused differences in social strata that function to show individual behavior in society which could be grouped in wayed of communicated as well as socialized. Methods in this study was a qualitative descriptive approach, with aimed an effort to revealed the socio-cultural aspects in the novel Anthology of Rasa by Ika Natassa

This time the writer used the Ralph Breaks The Internet: Wreck-It Ralph 2 movie as the object of the study which displayed audio and visuals about toxic friendship. In this study, the content analysis method was used which was a type of quantitative research with a descriptive content analysis approach. The results of this study classified into 6 toxic friendships, namely: jealousy, dependent, cunning, selfish, interfered and lied which were taken from a total of 80 scenes.

Sugiharti (2021) entitled "Friendship Depicted in James Dashner' Novel The Death Cure (2011): A Psychoanalytic Approach", same as Mustajib's discussion, this The writeralso took the topic of the meant of friendship, the characters from the novel The Death Cure and the writer's message conveyed the meant of friendship which was packaged used psychoanalytic

theory. In addition, used the psychoanalytic method, this study also used qualitative methods which analyze the characters, plot, and background to classify data, the type of data used was wrote documents which used primary data that came from the novel itself and secondary data came from books, articles or journals with the same discussion. The results of this study found that there were seven indicators in friendship, namely treacherous, giving support, affection, intimacy, argumentation, acceptance, and memories.

Rapa, et.al (2022) entitled "The Personality of Tifani Fanelli in Jessica Knoll's Novel Luckiest Girl Alive". The purpose of this study was to determine the personality and the factors that influence the personality of Tifani Fanelli. The author used a qualitative descriptive method that focused on a psychological approach where the data source comes from the Luckiest Girl Alive novel. The data were obtained from read, noted, and analyzed, while in categorized the data the author used Adler's individual psychology approach. The results of this study obtained several types of personality such as patient, innocent, obsessive, forgiving, dreamer, loyal, jealous, generous, emotional, and brave.

They had differences and similarities with the topic Friendship in The Candymakers by Wendy Mass that the writer would like to took. Not only instinct or the human subconscious, but also behavior that was directed to meet one's needs. He divided personality into 3 forms, namely, Compliant, Aggressive and Detached.

The writer used sociological theory by Alan Swingewood. According to Alan Swingewood in Wahyudi (2013) stated that sociology was a branch of the science of human interaction while sociology of literature described the relationship between humans and society in the scope of literature. Swingewood categorizes 3 sociological concepts of literature, namely literature as a reflection of the times, literature seen from the production process and literature in relation to history. And the writer focused on literature as a reflection of the times.

#### 3. METHOD

In this research, the writer used descriptive qualitative method by using Sociological approach. In this research, elements that would be taken as the research data from this novel were words, phrases, sentences, paragraphs and dialogues. # 5.3. The Impact of Personality of Main Characters In Novel The Candymakers By Wendy Mass That Affect Their Friendship
